This Acceptable Use Policy ("AUP") sets forth guidelines for the acceptable use of products and services provided by OdishaHost.com ("OdishaHost", "we", "us", or "our"). All customers, users, and visitors ("you", "your", "client", or "user") of our services must comply with this policy. Use of our services implies acceptance of this AUP.

1. Prohibited Content and Activities

1.1 Illegal Activities

- Violating any applicable local, state, national, or international law or regulation.
- Hosting, promoting, or distributing child sexual abuse material or any other illegal pornography.
- Engaging in fraudulent activities, including phishing, identity theft, or scams.

1.2 Abusive Behavior

- Sending spam or unsolicited bulk email (UBE).
- Operating email open relays or proxy servers.
- Launching denial-of-service (DoS/DDoS) attacks or attempting unauthorized system access.
- Harassment, threats, or encouraging violence or hate speech.

1.3 Infringement of Intellectual Property

- Hosting or distributing copyrighted material without proper authorization.
- Trademark misuse, piracy, or using copyrighted logos, software, or media unlawfully.

1.4 Resource Abuse

- Excessive use of server resources (CPU, RAM, bandwidth) that interferes with the normal operation of our infrastructure or impacts other customers.
- Hosting "mining" applications for cryptocurrencies without explicit permission.

2. Security Violations

You may not attempt to gain unauthorized access to any system or network. This includes:

- Port scanning or probing for vulnerabilities.
- Exploiting system bugs or vulnerabilities.
- Circumventing user authentication or security of any host, network, or account.

3. Email and Anti-Spam Policy

We enforce a strict no-spam policy:

- Bulk email must comply with applicable laws (e.g., CAN-SPAM Act, GDPR).
- You must maintain valid opt-in records.
- Use of purchased, rented, or harvested email lists is strictly prohibited.

- Shared hosting resources are meant for standard website operations.
- Hosting download portals, streaming services, or backup/data archive repositories is not allowed unless explicitly permitted.

- Legal action if damages are incurred due to your actions.
